Sub Private Schools – Chennai District - Change of Name from **P.S. Higher Secondary School** to **P.S.Senior Secondary School** proposals –Continuation of No Objection Certificate already issued vide L.Dis No.55546/E1/77 dt 02.05.77 - order – Regarding.

With reference to the above (1) and (2), the proposal for change of name of the School and revalidation of No Objection Certificate already granted was considered. The **Secretary and Correspondent of the P.S. Educational Society** has submitted an affidavit dated 10th January 2023 that the name '**P.S. Higher Secondary School**' will not be used in future. The Secretary and Correspondent of **P.S. Educational Society** has also

conducted a meeting of the board trustees of the trust on 11.04.1979 and 18.04.1979 and communicated the minutes of the copy wherein it was unanimously decided to change the name of the school run by the Trust from **“P.S. Higher Secondary School”** to **“P.S. Senior Secondary School”**. It is stated that in the extension of general affiliation order dated 05.02.2019 one of the conditions was to change the name of the **‘P.S. Higher Secondary School’** to **“P.S. Senior Secondary School”** Based on this, the change of name is approved subject to the condition that the Secretary provides a detailed report on the name change carried out in all documents as required by the affiliation bye-laws.

The **P.S. Senior Secondary School** was issued with permanent Affiliation by the Central Board of Secondary Education (CBSE) from the year 1986 Vide Order No CBSE/Aft/19332/17890-92 dated 25/08/86 by Joint Secretary Affiliation. The school was granted extension of General Affiliation up to Senior Secondary level beyond 31/03/2019 for the period 01/01/2019 to 31.03.2024 Vide order No CBSE/AFF/1930032/EX-00363-2021/2019.

It is stated that as per letter by the Secretary and Correspondent dated 09.01.2023 the school was issued with No objection certificate to follow the syllabus of middle classes as approved by the Central Board of Secondary Education vide letter L.Dis.No.55546/E1/77 dated 25.04.77 by the Director of School Education. The said letter copy in original has been lost and they have lodged a complaint with Mylapore E1 Police station with CSR No 11.2023. As per the non traceable certificate issued by the Inspector of Police, E1 Police Station, Crime, Mylapore, Chennai-4, that the said certificate is untraceable based on the CSR No.11/2023. In the provisional affiliation of the order copy issued by the Central Board of Secondary Education dated 16.5.1979 the name of the school is mentioned P.S.Senior Secondary School. Moreover, as per the true copy of NOC, for the middle classes in respect of P.S. Higher Secondary School the syllabus of the Central Board of Secondary Education was approved. No objection proceedings as per the copy already issued has the name as **“P.S. Higher Secondary School”**.

It is stated that in the extension of general affiliation order dated 5/09/2019, one of the conditions was to change the name of the P.S Higher Secondary School to P.S.Senior Secondary School.

As per CBSE norm 'No Objection Certificate' once issued is valid till it is withdrawn. Since the Central Board of Secondary Education has already granted extension of affiliation vide letter no. CBSE/AFF/1930032/EX-00363-2021/2019/1516317 dated 05.09.2019 and Certificate of Recognition issued vide letter R.C.No.13919/G1/S1/2018 dated 05.04.2018 by the Director of School Education, the P.S.Senior Secondary School is permitted to function with the affiliation of Central Board of Secondary Education.
